



Swim and Fitness Membership Registration Information, Policies and Procedures

Registration for all Aquatic Adventures Ohio programs operate on a first come, first serve basis. Pool availability is subject to change. Members should reserve a lane and classes using the online and mobile app before visiting the facility.

Punch Pass and Monthly Membership Holders

The punch pass membership expires when all visits have been utilized or one year from the date of purchase.

The punch pass membership may be used for two additional swimmers or fitness participants; however, all names must be listed on the membership registration and all parties must complete a membership registration form acknowledging the policies and procedures and waiver release.

All punch pass holders are expected to observe the safety and operation rules and regulations of the facility. Any changes or revisions to policies will be made at the direction of Aquatic Adventures Ohio leadership and will be posted and communicated to all pass holders.

Aquatic Adventures Ohio reserves the right to revoke any pass and/or impose evictions from the facility and grounds. Any pass holder who fails to comply with the policies and procedures, exhibit conduct considered improper, or any infringements caused to other patrons will be grounds for action.

Punch pass and monthly holders use the facilities at Aquatic Adventures Ohio at their own risk. Aquatic Adventures is not responsible for lost or stolen articles in the facility or on the property.

Dependents must adhere to the following swim and fitness policies: Children 6 years and under must have an adult in the water and be within arm's reach of the responsible adult. Children ages 7 years and over must be accompanied by a responsible adult who intends to directly supervise them the entire visit. Fitness participants must be the age of 16 years or older to take classes.

Punch pass holders may not use the pass to instruct other members while on the pool deck. If a person/member needs a coach, a lane must be rented and proof of insurance must be provided, naming Aquatic Adventures Ohio as an additional insured for \$1 million in general liability coverage.

Fitness Class Policies

Attendance Policy

- Cancellations of reserved classes or lanes must be completed by a member 8 or more hours in advance for no penalty.
- Class no shows or cancelations less than 8 hours from the start of class will result in the following penalties:
 - First Time No Contact/No Show will receive a notice
 - Second absence and subsequent absences will be charged a \$20.00 fee or loss of punch on pass inside the 8-hour window on the account on file
 - If multiple absences occur, membership will be revoked
- Members will have until 10 minutes after the classes has started to join classes. After 10 minutes, you will no longer be able to join the class, and your spot will be forfeited to the first person on the waitlist.

Fitness Membership Cancellation

When signing up for a fitness membership, you are not held to a contract. Members can cancel their memberships at any time. A 30 day notice is required to avoid next month's billing cycle. No prorated refunds will be given. Once membership is cancelled, member can use membership for the remainder of the month. Once membership is cancelled, member can attend classes for the time remaining.

Changing Room Policy

Only children 5 years and younger are permitted to be in the locker room of the opposite sex. Children 6 years and over (School Age Classes and above) are to use the locker room of their own sex. If you do not feel comfortable sending them into the locker room by themselves, you may use the restrooms on the west side of the pool deck. Lockers may be available for use during your swim or fitness session.

Weather Policies and Other Closings

Swim and Fitness programs will be cancelled when Franklin County is under a Level 1 or Level 2 snow emergency. Visit our web site and social media for closure notices.
